MEMBERSHIP TYPES

Regular: Any firm, partnership, or corporation headquartered in North America that manufactures plastic composite decking products is eligible for Regular Membership in the Association upon terms to be fixed by the Board of Directors.

Associate: Any firm, partnership or corporation engaged in supplying components, equipment or services for the manufacture or installation of plastic composite decking products may be admitted to Associate Membership in the Association. Associate members shall have the rights, privileges and obligations of membership except the right to vote.
